William Cooke, Jr. was a son of William Cooke and Mary Blackborne of Bristol, Gloucestershire, England. Joan Roper was a daughter of Hugh Roper of Burnham, Somersetshire, England.

It has been speculated that William Cooke, Jr. was born en route to or in Virginia, because his birth is not recorded in St. Augustine Parish records in Bristol.² However his father is not known to have been in Virginia prior to 29 September 1664 when, with William Miles, he obtained a patent for 1100 acres in Isle of Wight County on the Blackwater River.³

The children of William Cooke and Joan Roper are identified in a sketch of the Cooke family, including a daughter who was married to Samuel Hargrove (Hargrave).⁴ In his will dated 14 March 1717/8 and proved on 20 August 1718, Samuel Cornwell (Cornwall, Cornell), who was married to Sarah Cooke, mentioned his brother-in-law Samuel Hargrove.⁵

William Cooke, Jr. was in Virginia by 03 February 1664 when he got a patent for 360 acres in Isle of Wight County. The tract was bounded by a line beginning in a meadow at the head of the "black water" and running southwest. The patent was obtained against the head rights of eight persons whose transportation expenses to Virginia were paid by William Cooke, Jr.: Ann Dichfeild, John Wall, James Turpin, John Legar, William Jordan, Thomas Harper, William Fuell and Jone Legg.⁶

The Blackwater River is presently the western boundary of Isle of Wight County, dividing it from Southampton County, which was erected in 1748 from parts of Isle of Wight and Nansemond counties.⁷

William and Joan Cooke sold the 360 acres that were granted to him on 03 February 1664 to Thomas Woodward on 10 November 1665. William Cooke, Jr. was involved in several land transactions in Isle of Wight County.⁸

On 09 April 1665 William Cooke, Jr. appointed "George Stoat of Bristol, England, to receive of my wife's brother, Hugh Roper, legacy left by her father." 9

As William Cooke, Sr., he made his will on 17 May 1698. It was proved on 09 August 1698. He left plantations to his sons, John, William (III) and Reuben. He bequeathed his home plantation to his wife Joan for her lifetime and after her death it was to go to his son Thomas who was not yet 21 years of age. The will was witnessed by Peter Vasser, Peter Hays and James Atkinson.¹⁰

Joan Roper Cooke married (2) John Carrell. As Joan Carrell, she made her will in Isle of Wight County in 1720 with bequests to Elizabeth Weaver and Joanna Burrah.¹¹

The parents of Hannah Atkinson Gee, who married Reuben Cooke, have not been determined, but she apparently was the widow of Charles Gee whose estate was affirmed by Hannah (Hanah) Gee, John Cooke, William Cooke and William Heath in Surry County on 05 July 1709. The surviving children of Reuben Cooke and Hannah Atkinson Gee are named in his will which was dated 19

November 1750 and proved in Isle of Wight County Court on 01 August 1751.13

Reuben and Hannah were not married until after her involvement with the estate of Charles Gee in 1709, but they could have been married shortly after July 1709 and had their children beginning in 1710-1711. If their son William was born by 1711, he would have been old enough to have a son William, Jr. about 1730. However only one daughter was married when Reuben wrote his will in 1750, so their children may have been born later than 1711.

Apparently as an afterthought, Reuben Cook (as his name was signed) left only 5 shillings to son William Cook in his will which suggests that William was the oldest son, already in receipt of his basic inheritance. First born sons were generally named for their paternal grandfather which supports the probability that William was the first born. It is possible that William Cook, son of Reuben Cook and Hannah Atkinson Gee, was the William Cook who married Ann Griffith and had William Cook, Jr., who was born about 1730, resided in Halifax County, Virginia, in 1767, and later in Pittsylvania and Henry counties, Virginia, before going to Kentucky where he died about 1790. Henry County came from Pittsylvania County in 1776. Pittsylvania was erected from Halifax County in 1766. Halifax was formed from Lunenburg County in 1752. Lunenburg came from Brunswick County in 1746. Brunswick was established from Surry County in 1720. Surry was erected from Isle of Wight County in 1652.

William Cook, Jr. of Henry County, Virginia, who was born about 1730, was associated there with Frederick Rives (Reeves) in 1788 as a deed witness and as justices of the peace. This indirect relationship with the Rives family provides continuity with William Cook IV of Surry County, who married Elizabeth Rives, a daughter of Colonel William Rives and Elizabeth Foster.¹⁴

Hannah Jones, who married John Cooke, and Rebecca Jones, who married William Cooke III, were daughters of James Jones.¹⁵ In his will dated 06 April 1719 and proved in Prince George County on 12 May 1719, James Jones left daughter Rebecca 200 acres of land in Surry County, daughter Hannah a negro named Jack, and his granddaughter Jone Cooke, daughter of John Cooke, a negro named Amy, 100 acres of land in Surry County and some livestock and household goods.¹⁶

Avis Killingsworth, the second wife of John Cooke, was the widow of William Killingsworth whose will was proved in March 1709/10.¹⁷ John Cooke witnessed, with Sarah Bullivant and Mary Underwood, the will of William Killingsworth on 29 November 1709. Proved on 07 March 1709/10 in Surry County, the will named wife Avis as executrix and distributed land to sons William and John Killingsworth. Daughter Lucy Gulledge was bequeathed a hog.¹⁸ The will of Avis Cooke (Cook) was dated 09 June 1711 and proved in Surry County on 15 August 1711. It contained bequests of clothing to daughter-in-law Elizabeth Cook (wife of Henry), and daughter Lucy Gulledge (Guillidge). Sons William and John Killingsworth also received legacies.¹⁹

Mary Jones, who married Thomas Cook, was a daughter of Arthur Jones and Susanna King.²⁰ With the consent of her husband Arthur Jones, Susanna King Jones devised the land left to her by her father Henry King to her daughters Elizabeth Jones and Mary Jones in her will dated 19 December 1691 and proved on 26 May 1713.²¹ Arthur Jones was transported to Virginia by William Cook, Sr.

Samuel Cornwell, who married Sarah Cooke, must have been Samuel, Jr. On 14 September 1683 Edward Rowell, William Foreman and Charles Williams were ordered to pay to Samuell, Elizabeth, Mary and Susannah, orphans of Samuel Cornell, deceased, their part of their late father's estate

when of age. Katherine Cornell paid the costs of admitting the estate of Samuell Cornell to probate prior to 26 September 1680.²²

Sarah Cooke Cornwell was alive as late as 21 June 1721 when she received a payment from the estate of Robert Tharpe which was administered by Sarah Tharpe.²³

John Cooke apparently was not a land-owner but a tenant. The will of John Watkins, dated 05 November 1703 and proved on 05 March 1708, bestowed "the plantation where John Cooke live" to one of his sons, John Watkins, Jr.²⁴

The will of John Cooke, dated 10 April 1711 and proved in Surry County on 20 June 1711, named his wife Avis Cooke as executrix:²⁵

Henry Cook moved to Brunswick County where he first lived in St. Andrews Parish and then in Meherrin Parish where he died at age 82. His will was dated 13 November 1772 and proved on 23 July 1774. He had a number of tracts of land in Brunswick County by patent and by purchase.²⁶

The surviving children of Thomas Cooke and Mary Jones were named in his will, dated 21 January 1735/6 and proved in Isle of Wight County on 22 November 1736. Mary Jones Cooke apparently died before Thomas, as she was not mentioned in it. Thomas must have been fairly young when he died since none of his daughters were married at the time of writing:²⁷

The surviving children of William Cook III are identified in his will dated 01 May 1740 and proved on 19 November 1740. His wife Rebecca must have died first since she was not mentioned in the will:²⁸

William Cook (III?) was granted 250 acres in the Upper Parish of Isle of Wight County on 29 April 1693. Located between the third swamp and the main Black Water, the tract adjoined Doctor Williamson, Mr. Thomas More and Edward Boykin. The land had been patented previously to John Proctor on 20 April 1685, but was deserted by him and re-granted to William Cook by a court order in return for his having imported 5 persons to the colony.²⁹

The land of William Cook III in Surry County was on the main Blackwater Swamp. On 16 June 1727 he received a patent for 190 acres in Surry County on the south side of the main Blackwater Swamp adjoining his cornfield.³⁰ Some of his neighbors in the area, as identified from various patents, were Josiah Barker, Johne (Jehue) Barker, Jethro Barker and Peter Bagley. Old Town Swamp and Licking Marsh Branch were nearby since they were boundaries for the land of Josiah Barker.

A patent for 175 acres in Surry County, on the south side of the main Blackwater Swamp adjoining the land of James Jones, was issued to William Cook, Jr. (IV) on 18 February 1722. On 16 June 1727 William Cook, Jr. (IV) got another patent for 175 acres in Surry County on the south side of the main Blackwater Swamp adjoining William Cook (III or IV?) and James Jones. In the meantime, William Cook, Jr. (IV) of Surry County obtained a patent for 310 acres of land in Brunswick County on the south side of the Meherrin (Maherin) River and the south side of Fountains Creek adjoining John Scott and John Vintson.³¹

Elizabeth Rives, who married William Cook IV, was a daughter of Colonel William Rives and Elizabeth Foster.³²

Elizabeth Cook, daughter of William Cook and Rebecca Jones, was identified as the wife of Thomas

Chappell.³³ Thomas Chappell and Elizabeth Cook apparently were first cousins. He inherited 100 acres of land in Surry County from his grandfather James Jones,³⁴ so he must have been a son of a sister of Rebecca Jones Cook. Chappell sold this tract to William Cook IV.³⁵ Elizabeth Cook Chappell married (2) Thomas Tomlinson,³⁶ but she must have died before he made his will on 01 January 1750 since she is not mentioned in it. Witnessed by Joseph Carter and Henry Gee, the will of Thomas Tomlinson was proved in Surry County on 19 March 1750. His heirs were sons William Tomlinson, Thomas Tomlinson and Benjamin Tomlinson and daughters Sarah Carter, Elizabeth Moss and Amy Carter.³⁷ Thomas Tomlinson had patents for three tracts of land, 195 acres in Surry County on the south side of the main Blackwater Swamp adjoining Colonel William Randolph, deceased, and the "Colledge" land by patent dated 31 October 1716, 80 acres in Surry County on the south side of the main Blackwater Swamp and along Warwick Swamp by a patent dated 22 June 1722, and 325 acres in Brunswick County on the south side of the Meherrin River and northeast side of Cattail Creek by a patent dated 31 October 1726.³⁸

James Anderson got a patent for 308 acres in Prince George County on the west side of Butterwood Swamp on 05 September 1723. He obtained 100 acres in Surry County on the south side of the main Blackwater Swamp and the north side of Pidgeon Swamp by a patent issued on 05 September 1723.³⁹

Henry Mitchell, Jr. received a patent for 327 acres of land in Prince George County on Jones Hole Swamp and the Trading Branch on 15 July 1717. Henry Mitchell was granted 150 acres in Surry County on the north side of the Nottoway River and the line between Surry and Prince George counties, adjoining Peter Mitchell, on 05 September 1723. He got 100 acres in Surry County on the north side of the Nottoway River and the south side of Jones Hole Swamp, adjoining his own land, on 16 June 1727. On 28 September 1732 Henry Mitchell, Jr. obtained 200 acres in Surry County on the south side of the Nottoway River, the north side of Reedy Branch and the line between Surry and Prince George counties. adjoining his own land and that of Thomas Mitchell and John Mitchell, Jr. 40

Mary Cook Briggs apparently outlived her husband. The Surry County will of William Briggs, dated 08 February 1748 and proved on 19 April 1748, made bequests to his wife Mary and appointed her executrix. He left land in Surry and Brunswick counties to his brother Thomas Briggs, to a cousin Hincha Gilliam, and to sons John, William and Henry Briggs. Daughters Elizabeth Chappell, Mary Chappell, Amy Briggs and Lucy Briggs received negroes and personalty. The will was witnessed by John Hay, Edmund Ruffin, Willet Roberts and John Irby.⁴¹

Michael Hill was granted 225 acres of land on the south side of Jones Hole Swamp in Prince George County on 22 June 1722.⁴²

The land of Michael Hill in Prince George County and the land of Henry Mitchell in Surry County was on Jones Hole Swamp which lay in both jurisdictions. In 1699 a tract of land in Charles City County was described as being between Josephs Swamp and "Jones Hole, otherwise called Barlethorpe Creek in new rutland on N. side of Nottoway Riv." Subsequent to 1702 patents for land on Jones Hole Swamp were ascribed to Surry and Prince George counties. Prince George County was formed from Charles City County in 1703.

Michael Hill and Susannah Cook, Richard Gary and Hannah Cook and Henry Mitchell and Sarah Cook resided in Bristol Parish:⁴³
