Jones Johnson was an heir and apparently a son of Jesse Johnson who died in Madison County, Kentucky, in 1822. Mary "Polly" Crook was a daughter of Absalom and Mary Ann Crook of Madison County where Absalom died about 1806.

The marriage bond for Jones Johnson and Polly Crook was dated 15 March 1815 and the minister's return gives a date of 01 March 1815 for the wedding:<sup>3</sup>

This shall oblige us our heirs &c to be held & firmly bound unto the Comealth of Kentucky in the penal sum of £50 rendered yet upon Condition that if there shall be no lawful cause to obstruct the Marriage intended to be solemnized between Jones John son & Miss Polly Crook daughter of Absa. Cook decd. approbation having been given by Zachariah Crook her Bro. & with whom she resides then this obligation to be void else to remain in full force & Virtue Given under our hands & seals this 15 March 1815

The marriage rite was performed by Abraham Cook, minister of Indian Fork Baptist Church which is situated in Shelby County near the Franklin County line:<sup>4</sup>

These to marry Jonas Johnson and Polly Crook executed the 1st of March

The signature of Jones Johnson is very legible, suggesting that he was capable of writing.

Since the date of marriage preceded the date of the license, perhaps the date of marriage was intended to be the 21st or 31st of March. In any event, a March marriage for Jones Johnson and Polly Crook was only five months before their first child was born 21 August 1815. The birth dates of Jones, Polly and their children appear on a family record that was inserted in, but not an integral part of, the Bible of William Wade who married Louisa Crook Johnson. This family record was described as being very old and fancy by Ronald Harrod of Bagdad, Kentucky, who copied the information in 1976 when the Bible was in the possession of Dorothy Hedges of Bagdad. The death date of Louisa Johnson Wade was also in the Bible. Ron Harrod interpreted the name Jones as James and the middle initial of William Logan Johnson as J. in his transcription:<sup>5</sup>

An indenture by the heirs of Jones Johnson includes Logan Johnson which indicates that William Logan Johnson went by his middle name. Robert and Fountain undoubtedly did not participate in the deed because they were minors. The name of Louisa Johnson who married William Wade was

written Eliza throughout the document, by the recorder who copied the original deed for entry in the record book, excepting for her signature which was copied correctly as Louisa:<sup>6</sup>

Preston Carr apparently did not sign the deed or his signature may have been left off the recorded copy inadvertently. A space for his signature appears, followed by a mark indicating his seal. Perhaps he did not sign it because he died between the preparation of the deed in 1845 and its signing and acknowledgment by Elizabeth Johnson Carr in 1849.

Preston Carr and Elizabeth J. Johnson obtained a license to marry on 20 March 1839 with the consent of her father Jones Johnson. They were married by Abraham Cook on 21 March 1839.<sup>7</sup> Although she was a resident of Platte County, Missouri, when she participated in the 1845 deed, Elizabeth Johnson Carr apparently lived in Shelby County, Kentucky, in 1855 when she seems to have married for the second time:<sup>8</sup>

Miles, John of Shelby, age 39, widower, b. Shelby, and Elizabeth Carr of Shelby, age 18, widow of Preston Carr, married 23 July 1855, bond by A. P. Hickman

If this was Elizabeth Johnson Carr, her age was either entered wrongly on the bond or transcribed erroneously since she was not 18 but 40 years old in 1855. Of course, this could pertain to another Preston Carr with a widow named Elizabeth who actually was only 18 years of age. However there are no other marriages by a Preston Carr in Shelby County records.

The name of the father of Sally P. Johnson was transcribed from her marriage bond as James Johnson:9

Sarah Johnson Christie probably died in Missouri where she resided in 1845.

William Wade who married Louisa Crook Johnson was a son of Royal Wade and Rachel Jones who came to Kentucky from Franklin County, Virginia, about 1792. William and Louisa also were married by Abraham Cook:<sup>10</sup>

I do certify that I did, on the 24 day of October, 1844, celebrate the rites of matrimony between William Wade and Louisa C. Johnson of this County, agreeably to the rules of the church to which I belong. Witness my hand this 24 day of October, 1844

Mary Crook Johnson and her two youngest sons lived with William Wade when the Federal census was enumerated in Shelby County on 08 October 1850:<sup>11</sup>

The relationship of E. Johnson, aged 40, to this family group has not been established but she probably was Elizabeth Johnson Carr, actually aged 35 and widow of Preston Carr, who was identified to the census taker as a daughter of Polly Johnson, and mistakenly enrolled by her maiden name.

Mary Ann "Polly" Johnson married Anderson Wade, brother of William Wade who married Louisa Crook Johnson, in Shelby County on 01 September 1847. Polly Johnson was the second wife of Anderson Wade. They and their children were enumerated with Anderson's father Royal Wade, next to William Wade in 1850:13

Mary Ann Johnson must have been named for her grandmother Mary Ann Crook.

Polly Crook Johnson was residing with her son-in-law Anderson Wade in the area of Christiansburg Post Office, District 2, Shelby County on 29 June 1860 when the census was taken:<sup>14</sup>

Polly Crook Johnson apparently died after the 1860 census since she has not been found on the 1870 enumeration. Anderson Wade and Mary Ann "Polly" Johnson were tabulated on 22 June 1870 in Jacksonville Precinct, Jacksonville Post Office, Shelby County:<sup>16</sup>

Robert W. Johnson and Mary A. Johnson, daughter of Jesse Johnson, deceased, and Prudence Johnson, married on 25 February 1852 with Abraham Johnson as surety on the bond.<sup>17</sup> Jesse Johnson (Johnston) married Prudence Cook, daughter of Abraham Cook, on 23 December 1823 with Israel Christie as bondsman.<sup>18</sup> The wife of Abraham Cook, the Baptist preacher, was Sarah Jones, a sister of Rachel Jones Wade, mother of William Wade who married Louisa Johnson.<sup>19</sup>

Elizabeth Cook who married Fountain Johnson was a daughter of Wesley B. Cook who gave his consent for the marriage bond 04 May 1852. Fountain and Elizabeth were married 05 May 1852 by G. D. Rucker.<sup>20</sup> Wesley Cook was a brother of Prudence Cook who married Jesse Johnson. The relationship between Jones Johnson and Jesse Johnson (Johnston) of Shelby County has not been determined but their land was adjoining, so Jesse may have been Jones' youngest brother, who was born after their father's death in Madison County, Kentucky.

Elizabeth Johnson, daughter of Jesse Johnson of Madison County, married Hezekiah Crook, a brother of Polly Crook who married Jones Johnson, which substantiates the probability that Elizabeth Johnson Crook and Jones Johnson were siblings. Both Elizabeth and Jones were legatees of Jesse Johnson but in his will, dated 14 March 1822 and proved on 06 May 1822 in Madison County, Jesse did not specify his relationship to Jones.<sup>21</sup> Jesse made bequests to his wife Sally Johnson; to his daughter by her, Susannah Johnson; to his daughter Polly Burris; to his daughter Elizabeth Crook; to

his son Robert Johnson; to his son Starling (Sterling?) Johnson; to Sally Burrus; to Jones Johnson; to George Johnson; and again to Robert Johnson.

The probability that Jones and George Johnson were sons of Jesse is substantiated by the fact that Jesse Johnson had four males, probably sons, residing with him in Madison County in 1810:22

Born in 1792, Jones Johnson could have been the male aged 16-26, with Robert, Starling and George as the others. Sometime between 1810 and 1815, Jones followed the Crook family to Shelby County and married Polly Crook. Of course, Jones and George could have been nephews, residing with their uncle Jesse.

Jones Johnson was counted on the 1820 census of Shelby County with his bride and first children but the enumeration was faulty:<sup>23</sup>

The three males under 10 should have been three females; daughters Elizabeth, Sarah and Louisa, who were born in 1815, 1817 and 1819, respectively. Also wife Polly was marked in the wrong column. Born in 1788, she would have been 32 in 1820 and tabulated in the 26-45 group.

The 1830 census gives an accurate representation of the family of Jones Johnson:<sup>24</sup>

Jones Johnson had six children at home in Shelby County in 1840:25

Jones Johnson owned a tract of land in Franklin County, Kentucky, on the headwaters of Big Benson Creek prior to 12 November 1824 when he and his wife Mary Johnson sold it to Collier Brown. Although they were enumerated as residents of Shelby County on the 1820 and 1830 censuses, the deed identified them as residents of Franklin County:26

p.35, Indenture, November 12, 1824, Jones Johnson and Mary Johnson, his wife, of Franklin County, Kentucky, to Collier Brown of Woodford County, Kentucky, for \$150, a tract in Franklin County on the head waters of Big Benson Creek, beginning corner to John Mitchell, thence northeast. Recorded by the Kentucky Court of Appeals, October [?] 12, 1824, at which time Mary Johnson relinquished her rights of dower.

Franklin County records have not been researched for the deed by which he acquired this land. Nor has it been discovered when or how Jones Johnson became a landowner in Shelby County, Kentucky. Deeds by which he purchased land there have not been located in the records but there are a number of indentures of sale and mortgage by him recorded there. His land was in the northwest section of the county which is drained by Six Mile and Benson creeks, near Franklin County, on the road from Frankfort to New Castle. From the quantities of bacon mentioned in two of the mortgages, it appears that he raised hogs and cured their meat for commercial purposes. Jones Johnson signed all of his deeds without a mark but Polly Crook Johnson signed with an X mark.

On 27 April 1837 Jones Johnson of Shelby County, Kentucky, sold 1 1/8 acres in Shelby County on the waters of Benson Creek to William H. Constantine of Shelby County for \$105. The lot was on the south side of the road from New Castle to Frankfort and bounded from a stone in the line of J. B. Russell along the south side of the road 22 poles to the line of Jones Johnson, then southwardly on that line 7 1/3 poles to a corner of Jones Johnson, then eastwardly 22 poles to the line of J. B. Russell, then with his line northwardly 7 1/3 poles to the beginning. The deed was signed Jones Johnson and acknowledged by him in Shelby County Court on 27 April 1837.<sup>27</sup>

Jesse Johnson, father of Mary A. Johnson who married Jones Johnson's son Robert, died before 11 November 1841 when Jones Johnson sold land in Shelby County adjoining that owned by the heirs of Jesse Johnson. Jones Johnson of Shelby County conveyed 107 acres there on Six Mile Creek to Samuel Miles of the same place for an unstated amount. The bounds of the tract began at a corner with James Miles, east 80 poles to a corner of Jones Johnson, south 209 poles to a corner to the heirs of Jesse Johnson, west 80 poles and north 220 poles to the beginning. Polly Johnson, the wife of Jones Johnson, joined with him in this conveyance and relinquished her dower right in the body of the indenture but the file copy does not include her signature nor a certification that she appeared in court to acknowledge the sale. It was signed Jones Johnson and acknowledged by him on 10 January 1842.

On the same day Samuel Miles and his wife Sally sold 130 acres in Shelby County on Six Mile Creek to Jones Johnson for \$2003. The boundaries went down a branch to the line of R. Dobson, then south to the line of Kirkendall, east to a stone, south 70 poles to a stone marked No. 4, east 98 poles to a stone, north 66 1/2, east 15 poles to a stone, north 85 1/2, east 53 1/2 to a stone, north 60 poles to a stone marked L in Kirkendall's line, then to the beginning. Sally did not sign the deed nor did she acknowledge it with Samuel in Shelby County Court on 10 January 1842.

Also on the same day Jones Johnson mortgaged 60 acres of land on Six Mile Creek to William R. Roberts for \$440. The tract was bounded by Edmund Johnson, Israel Christie, Richard Dobson, Abraham Miles and others unnamed. The loan was due on 01 September 1841 by a note that bore the same date as the mortgage, on 11 November 1841 which is puzzling. Jones Johnson acknowledged the deed on 10 January 1842.

Edmund Johnson probably was one of the previously mentioned heirs of Jesse Johnson.

Also on 11 November 1841 Jones Johnson mortgaged 100 acres in Shelby County on Benson and Six Mile creeks to Samuel Miles and Henry Bohannon for \$1000. On the road from Frankfort to New Castle, the land adjoined John and Henry Childers, the heirs of Abraham Kesler and Samuel Miles. The note, bearing the same date as the indenture, was due that same date. Signed by Jones Johnson, it was acknowledged on 10 January 1842.<sup>28</sup>

Jones Johnson acknowledged a mortgage in Shelby County Court on 31 July 1843 from him to Daniel B. Duncan and John W. Gale for \$500 for 30 acres on Six Mile Creek, adjoining Isaac Miles and George D. Rucker on the road from Frankfort to New Castle, plus 1 wagon, 5 horses, 90 stock hogs, 6000 lbs. of bacon and lard, 6 beds and bedding and 5 head of cattle. The mortgage, due on 01 April 1845, was signed by Jones Johnson.<sup>29</sup>

On 23 December 1843 Jones Johnson of Shelby County sold 100 acres in Shelby County to Samuel Miles and Henry Bohannon for \$1000. The tract was at the intersection of Flat Creek Warehouse Road and the road from New Castle to Frankfort. It was surrounded by the lands of Isaac Miles, Henry Childers, Abraham Kesler and Samuel Miles. Jones Johnson signed the deed in the presence of William R. Roberts and Samuel G. Bohannon. He acknowledged it on 08 January 1844.<sup>30</sup>

On 02 January 1844 Jones Johnson of Shelby County mortgaged to William R. Roberts of Shelby County for \$266, 30 acres on Six Mile Creek, adjoining G. D. Rucker, Isaac Miles, Samuel Miles and Henry Bohannon, and 7 horses, 8 cattle, 30 hogs, a corn crop, oats, fodder, farming tools, 2 saddles, 3000 lbs. of bacon, 6 featherbeds with sheets and clothing, 1 mantle clock, 1 bureau, 1 cupboard with all ware, 1 dozen chairs, all kitchen furniture and 2 tables. The mortgage was due on 02 January 1844 by note bearing same date. It was signed by Jones Johnson and witnessed by William L. Johnson and Jeptha Johnson. It was acknowledged in Shelby Court by Jones Johnson on 02 January 1844 and proved by William L. Johnson and Jeptha Johnson. A marginal notation indicated that this loan was repaid.<sup>31</sup>

Jones Johnson made a mortgage with Parmenas Hansbrough on 10 February 1844.32

Jones and Polly Johnson were living in Franklin County, Kentucky, on 09 August 1844, when they conveyed to Henry Bohannon, executor of Edmund Johnson, deceased, of Shelby County, for \$1200 previously received from the deceased, 40 acres on Six Mile Creek in Shelby County bounded by John Radford, then north 89 7/8, east 921/10 poles to James Miles, north 1 5/8, west 69 3/4 poles to James Miles, south 898/10, west 92 2/10 poles to Betsy Neal, south 1 5/8, east 69 1/2 poles to the beginning. The deed was signed by Jones Johnson and marked by Polly Johnson and acknowledged by them in Franklin County Court on the same day, when Polly was examined privately for her concurrence.<sup>33</sup>

Logan Johnson apparently was living in Henry County, Kentucky, in 1844. A conveyance from William L. Johnson of Henry County that year, which did not give the day or month, conveyed for 1 cent to Henry Bohannon of Shelby County, executor of Edmund Johnson, deceased, 52 1/2 acres in Shelby County on Six Mile Creek bounded by on the east by John Radford, the north by Jones Johnson, the west by William and Abraham Miles and Abraham Cook, Sr., and on the south by

Abraham Cook, Sr. The deed was signed by William L. Johnson who acknowledged it in Henry County Court on 13 September 1844.<sup>34</sup>

On 10 August 1844 Samuel and Sarah Miles sold land in Shelby County to John W. Gale that adjoined John Johnson, Betsy Neal and a lot belonging to Indian Fork Church. On the same day Henry Bohannon, executor of Edmund Johnson, sold land in Shelby County to John W. Gale that adjoined Betsy Neal and James Miles.<sup>35</sup>

Robert Warren Johnson, who would have been 35 in 1850, apparently was living with John Johnson of the Christiansburg post office area in Shelby County in 1860:<sup>36</sup>

Frances Cook probably was Frances Wilcoxson Cook, daughter of Daniel Wilcoxson and Sally Faulconer, who was born about 1782 and married Seth Cook, son of William Cook, Jr. and Margaret Jones, who died about 1840.<sup>37</sup> Martha Cook, daughter of Seth Cook, married John Johnson in Shelby County on 12 February 1851, with the consent of her mother. Robert Johnson was surety on the bond.<sup>38</sup>

John Johnson who married Martha Cook probably was a brother of Mary A. Johnson who married Robert Warren Johnson and a son of Jesse Johnson and Prudence Cook, who were married in 1852. Prudence Cook Johnson was a daughter of Abraham Cook and a niece of Seth Cook (Cook data of compiler). Susan F. Johnson probably was a daughter of Robert and Mary A. Johnson. Since Mary was not enumerated on the 1860 census, she must have died after Susan was born about 1857.

Abram (Abraham) Christie who married Sarah "Sally" Johnson was a son of Israel Christie and Elizabeth Cook. Abram Christie was born on 13 February 1818 at Christiansburg in Shelby County, Kentucky, and died on 10 June 1880 in Gentry County, Missouri, where he is buried in McFall Cemetery. The birth of Sally Johnson Christie was given in a family Bible as 06 August 1818, which conflicts with the date of 06 August 1817 as given in the Wade Bible. 06 August 1818 does not seem to be a possible date, given the birth of Louisa Crook Johnson on 25 April 1819. Sally Johnson Christie died at the home of her son Samuel Wilson Christie in McFall, Gentry County, Missouri, on 03 May 1909 and is buried in McFall Cemetery. Abram Christie and Sally Johnson had nine children as listed on the following family record:<sup>39</sup>
