John Utley Wade was an illegitimate son of Angelica Wade by John Utley III. (Goochland County, Virginia, Order Book 4, pages 452, 527.) Alice "Ally" Woodrum was a daughter of John and Mary Woodrum. (Goochland County, Virginia, Will Book 8, page 125.)

Angelica Wade swore that John Utley III was the father of her son John before the Goochland County Court in February 1739: (Order Book 4.)

Angelica Wade Comes into Court and makes Oath that John Utley, junr. is the Father of a Male Child named John Born of her body whereupon it is Ordered that a Capias do issue agst the said John Utley returnable to the next Court (February Court, 1739)

On the Complaint of Angelica Wade agt. John Utley, Junr. for getting a Bastard Child on her Body the said Angelica having made Oath to the same it is Ordered that the said John do give Security to save the Parish of St. James harmless from the maintainance of said Child and that he pay Costs (1739)

John Utley Wade and Alice Woodrum were married by the Reverend William Douglas in Goochland County, Virginia, on 21 October 1763: (*The Douglas Register*, William Douglas, edited, William Macfarlane Jones, J. W. Ferguson and Sons, Richmond, VA, 1928.)

John Utley Wade. 08 June 1770, the birth date of John Wade, has been attributed to Anderson Wade in certain family records but, since the baptism of Anderson Wade is not included in the records of the Reverend William Douglas, it is not likely that he and John were twins. Anderson must have been born about 1772.

The Reverend William Douglas came to St. James Northam Parish, Goochland County, on 12 October 1750. On 15 September 1753 he began keeping a record, which he stated was the first record kept for the parish, of marriages that he performed. He obtained a ledger in 1756 that became a permanent register for the parish and was maintained by him until his death in 1798. In 1756 he inserted many of the prior marriages which he had conducted and, at the request of some of the parents of the congregation, he also added some birth records going back to 1705. The church for St. James Parish was Dover Church, which was the first church in Goochland County. It was authorized to be constructed on 11 February 1720 at a cost of 54,990 pounds of tobacco. It was to be 50 feet long and 24 feet wide. (*The Douglas Register*.)

Dover Church is on Route 621, which runs between Richmond and the town of Goochland, about three-quarters of a mile north of the village of Manakin, at the intersection of 621 and Route 6. Manakin is about thirteen miles from Richmond and twelve miles from Goochland. There is a St. James Church on Route 649, about one-half mile south of Route 6 and two miles east of Manakin. (State of Virginia General Highway map.)

The register contains no other references to John Utley Wade and Alice Woodrum, or their children although the family apparently resided in Goochland County until about 1788.

Before she married John Utley Wade in 1763, Alice Woodrum inherited 50 acres of land called "The Level" from her father John Woodrum by his will, which was dated 21 April 1760 and proved on 17 February 1761. (Goochland County Will Book 8, page 125.)

Somehow, perhaps through a mortgage, John Utley and Alice Woodrum Wade shared ownership of her inherited land, or at least part of it, with Bouth Napier. On 20 January 1779 John Utley Wade, his wife Alice and Bouth Napier, all of Goochland County, sold 40 and 1/4 acres to Miriam Pleasants of Powhatan County, Virginia, for 100 pounds current money. Known as The Level, the parcel of land was described as being part of a larger tract once possessed by John Woodrum and bequeathed by him to his daughter Alice in his will dated 17 February 1761. The piece of land adjoined Woodrum's spring and was on the old road next to lands of William Moore, Peter Walker and William Stamps. The three grantors signed the deed with marks. James Pleasants, John Cheadle and Thomas Royster witnessed the signing of John Utley Wade and Alice Wade. Bouth Napier signed in the presence of Turner Clerk, John Dowdy, William Sanders and Rene Napier. John Utley Wade and Alice Wade acknowledged the deed in Goochland Court on 21 June 1779: (Goochland County Deed Book 12, page 251.)

Miriam Pleasants ... one certain Tract ... containing by survey fourty & a quarter Acres being ... in the County of Goochland which said Tract ... is part of a larger Tract once in the possession of John Woodram Father to Alice the wife of the said John Utly Wade and the said Widram in his last will & Testament bareing date the seventeenth day of February 1761 did give and bequeath the same to his daughter Alice and her Heirs forever ... and is bounded from Widroms spring along the old Road to a corner pine on William Moores line thence along sd. moores line to a corner pine on Peter Walkers line thence along sd. Walkers line to a white oak thence on the sd. line to a corner Hickory at the Road on William Stamps line thence along Stamps line a direct course to the spring at the beginning and is known by that part of the land called the levell ... in witness whereof we have herewith set our hands and affixed our seals the day and year above written.

John Utley and Alice Woodrum Wade apparently retained about ten acres of the land that she inherited from her father. A record of ownership of other land by John Utley Wade has not been found. He was a taxpayer in Goochland County in 1782 with other Wades whose relationship with John Utley Wade has not been determined: (*Virginia Tax Payers, 1782-87*, Augusta B. Fothergill and John Mark Naugle, Richmond, 1940, reprinted Genealogical Publishing Company, Baltimore, 1978.)

John Utley Wade must have moved from Goochland County to Franklin County, Virginia, about 1788, after his son Castleton Wade married Judith Chancellor in Goochland County on 31 January 1787, with Julius Chancellor as bondsman, (Goochland County, Virginia, Marriage Register, page 36.) and before his daughter Susannah Wade married John Hale in Franklin County on 17 March 1789. (*Marriage Bonds of Franklin County, Virginia, 1786-1858*, Marshall Wingfield, 1939, reprinted Genealogical Publishing Company, Baltimore, 1973.)

David Willis was surety for John Hale and Susannah Wade, who were married by Robert Jones. Robert Jones, Jr. was a Baptist minister (Data of Gertrude Mann, Rocky Mount, VA, 1984.) and an uncle of Rachel Jones who married Royal Wade: (*Marriage Bonds of Franklin County, Virginia, 1786-1858*.)

Randolph Hall also was a Baptist minister in Franklin County.

John Utley Wade was identified as a resident of Franklin County, Virginia, on 12 November 1792 when he bought 193 acres of land on the south branch of the Pigg River in Franklin County from Joel Ragland of Goochland County for 50 pounds. The tract was bounded by land of Thomas Hutchings and a creek, with the boundary crossing a stream twice. The deed was witnessed by Dolly Wade, Evan Gillespie and John Frazier: (Franklin County, Virginia, Deed Book 2, page 459.)

This Indenture Made this twelfth day of November in the Year of our Lord one thousand Seven Hundred and ninety two Between Joel Ragland of the County of Goochland and State of Virginia of the one Part and John Utly Wade of the County of Franklin of the other Part witnesseth that the said Ragland for ... Fifty Pounds ... Have ... sold ... one Certain Tract or Parcell of Land Containing one Hundred and ninety three Acres ... situate ... in the County of Franklin on the south Branch of Pigg River and bounded as Follows Viz Beginning at Pointers in Thomas Hutchings thence His line ... Cross the fork ... Cross a branch ... white oak on the Creek thence up the same ... in witness whereof the said Joel Ragland Hath Hereunto Set His Hand and affixed His seal the day and year above written

The deed was proved in Franklin County Court in January 1793 by the witnesses and recorded.

On the same day Joel Ragland of Goochland County sold 97 acres on a branch of the Pigg River at Shoats Gap to John Frazier of Franklin County for 50 pounds. The bounds of the tract were described as being on "Shoats Branch ... Crossing the Branch ... on the side of nicholas's nobb ... Mavitys corner in Shoats Gap ... in Said Gap ... Crossing a Branch ..."

It was signed by Joel Ragland and witnessed by John Utley (Utly) Wade, whose mark was a large C; Evan Gillespie (Glaspy), who made a + mark; and Dolly (Dolley) Wade who marked with an X. It was recorded in January 1793. (Franklin County Deed Book 2, pages 461, 462, *Abstracts of the Eighteenth Century Deed Books of Franklin County, Virginia*, Volume I, Sara Motisher Beck, Franklin County Bicentennial Commission, Rocky Mount, VA, 1978.) The name Shoats should be spelled Choats (Choate's), a Franklin County surname.

John Utley Wade, who signed with a Z mark, witnessed the deed on 19 February 1793 whereby John Frazier of Franklin County, who signed with an X mark, sold this tract to Richard Hale of the same place, for 80 pounds current money of Virginia. It was described as being "... on Choats Branch ... in Raglands old line on the side of Nicholas Nobb ... Mavitys Corner on the ridge in Choats Gap ... Mavitys line ..."

Other witnesses were Henry Jones and John Hale, who signed with an O. It was recorded on 02 September 1793. (Franklin County Deed Book 3, pages 3, 4, *Abstracts of the Eighteenth Century Deed Books of Franklin County, Virginia*, Volume I.)

On 20 August 1794 John Utley Wade of Franklin County, Virginia, and his wife Alice, sold to John Huff of the same place, for 30 pounds of current money, 104 acres on Turner Creek, a fork of the Pigg River. Alice Wade acknowledged the deed and it was recorded in September 1794. (Franklin County Deed Book 3, page 177, *Abstracts of the Eighteenth Century Deed Books of Franklin County, Virginia* Volume I.)

A map of early settlers in the area of Franklin County, Virginia, shows John Utley Wade near the Pigg River Church in 1796, north of Turner Creek and adjacent to Thomas Jones and James Turner on the south prong of the Pigg River. Pigg River Church is west of Rocky Mount, Virginia, on Route 750 which roughly parallels the south prong of the Pigg River. The old Floyd Turnpike ran north of Route 750. Southwest of Rocky Mount, there was a Waids Stage Stop on the Carolina Road where it crossed the Pigg River, south of its intersection with the Floyd Turnpike. Wade's Gap was located in the mountains of northwestern Franklin County, west of Boone Mill. (*A Settlement Map of Franklin County, Virginia*, Mrs. Gertrude Mann, historian and researcher, J. R.

Waid's Stage Stop was named for Robert Waid, son of Moses Waid (Wade), who moved to Rockingham County, North Carolina. Wade's Gap was named for John Wade of a family that first settled in New Kent County, Virginia. (Data of Gertrude Mann.)

John Utley Wade died after 27 September 1798, when he wrote his will, and before December of that year, when it was proved in Franklin County Court. In his will he named his wife Ally, his sons Castleton, Royal, John, Anderson and Bradley, and his daughters Susannah Hale, Dorothea Troupe and Mary Wade. Thomas Jones, Jr. and William Akers were appointed as executors of the will, which was witnessed by John Mavity and John Frazier: (Photocopies of Franklin County will and inventory in possession of compiler.)

In the name of god Amen, I John Utly Wade of the County of Franklin and state of Virginia being sick & weak of Body, but of sound mind and memory, thanks be to god for his mercies, Calling unto mind the mortality of my body and that it is appointed for all men once to die do make and ordain this my Last will and Testament that is to say in the first place I Recommend my soul into the hands of god that gave it and my body to the Earth, to be decently Buried at the discretion of and as touching such worldly goods wherewith it hath pleased god in his mercy to bless me I give demise and dispose of the same in the following manner and form to wit First I direct my Executors to pay all my Just debts and funeral Expences out of my Personal Estate, Secondly I give unto my beloved Wife ally Wade one third part of all my Personal Estate together with one third part of the Land whereon I now Live for which I have a bond of Joel Ragland for a Title during her natural Life and I direct my Executors to use all Lawful means to Recover a title for said Tract of Land agreeable to said Raglands Bond for my two sons Bradley and Anderson Wade only Reserving my wifes dower to her during her natural Life and to my son John Wade I Give and bequeath one dollar to be paid out of my Estate and the rest of my Estate I desire to be Equally divided Between my sons Casleton Wade Royal Wade Bradley Wade and anderson Wade and my daughters Susanna Hale Dorothea Troupe, and Mary Wade, only my daughters Susanna Hale and Dorothea Troupe Shall allow out of their Shares ten dollars Each for a Cow Given to Each of them formerly only one mare and bed not to be sold but my wife to have it as part of her dwr. and I also Constitute appoint and ordain Thomas Jones Junr. & William Akers my whole and sole Executors of this my Last Will and Testament. In witness whereof I have hereunto Set my hand and affixed my seal this 27th day of September 1798.

After the death of John Utley Wade, Alice Woodrum Wade married (2) Owen Thomas Ruble, whose will was dated 06 March 1824 and proved on 06 December 1824. It was witnessed by Castleton Wade, John Hale and Jacob Troup. Ruble had been married previously. His legatees were his wife Ally Ruble, her daughter Polly W. Wade, and his own children, Jean Jones, Thomas W. Ruble, Elizabeth Hall, Swinfield Ruble and Margaret Conner. William Jones and John Jones were named as executors. John Hale and Jacob Troup proved the will in court. Abraham Jones and Robert Hairston were securities on the executors' bond in the amount of \$1500.00: (Franklin County, Virginia, Will Book 2, pages 619, 620.)

In the name of God Amen I Owen Ruble of the County of Franklin and State of Virginia being sick and low of body ... do make this my last will and Testament as follows To wit I give and bequeath to her my said wife Ally Ruble by her request all the Estate goods and chattles of every description whatsoever she was possessed of when I married her freely to be possest and enjoyed by her and her heirs forever. In addition to the above named agreement I give unto my beloved wife and her daughter Polly W Wade all my movable estate after my Death first all my lawful debts to be paid and funeral expences I give to my wife and her daughter Polly W Wade all the household and kithen furniture with all my Stock of every description and all my farming tools of every description (I desire so much of my movable estate be cept in my wifes hands for her support during life) As for my land I direct that my Executor sell the same for the best price they can get and make over the sales and divide the money between my children equal with what they have received heretofore ... Jean Jones, Thomas W Ruble, Elizabeth Hall, Swinfield Ruble, Margaret Conner. Also I appoint William Jones & John Jones my sole executors ... In witness I ... Owen Ruble have hereunto set my hand and affixed my seal this Sixth day of March One thousand eight hundred and twenty four, and of the Commonwealth the forty eight.

This will indicates that Alice Woodrum Wade Ruble lived until 06 March 1824 and that her daughter, Mary Wade, apparently did not marry, at least until after that date.

Judith Chancellor who married Castleton Wade was a native of Virginia. All of their

children were born in Franklin County, Virginia. Castleton Wade died in Franklin County, Virginia, in November 1825. His will was dated 09 July 1825 and proved on 07 November 1825. (Franklin County, Virginia, Will Book 3, page 205.) His heirs were his wife Judith and his children, John Wade, Thomas C. Wade, William Wade, Henry Wade, Lewis Wade, Josiah Wade, Castleton Wade, Jr., Chancellor Wade, Fleming Wade, Martha Kinsey (Keissey), Sarah Hale, Mary Franklin, who was deceased, Nancy Wade, and Allie Gillespie (Aley Glassey). His executor was Robert Hairston. The will was witnessed by David Young, Thomas Cunningham and Thomas Hale. (Data of Edith N. Day, Boulder Creek, CA, 1972.) The married name of Martha Wade was transcribed as Keissey but it was Kinsey. Edmond Kinsey and Martha Wade got a marriage bond on 08 February 1806, with Castleton Wade as surety. (*Marriage Bonds of Franklin County, Virginia, 1786-1858.*)

Mary Wade married John Franklin on 21 December 1816 in Franklin County, with Castleton Wade as bondsman. Sarah Wade married William Hale on 20 January 1817 in Franklin County, with Chancellor Wade as surety. Henry Wade married Polly Gillespie, daughter of Evan Gillespie, on 15 August 1820 in Franklin County, with William Gillespie as bondsman. Alice "Allie" Wade and William Gillespie were married on 20 October 1820, with Chancellor Wade as surety. Lewis Wade, who was born about 1797, married Elizabeth B. Hale on 21 July 1826 in Franklin County, with Francis Hale as bondsman. Chancellor Wade married Delilah Gillespie on 01 September 1835 in Franklin County and Evan Gillespie secured the bond. Although their names were spelled in their marriage records in different variations of the name Gillespie, as follows, the spouses of Henry Wade, Chancellor Wade and Allie Wade must have been related. Polly Gallaspie, who married Henry Wade, was a daughter of Evan Gallaspie and William Gillaspie was surety on her bond. When Chancellor Waid married Delilah Gallaspy, Evin Gallaspy was surety. The name of the husband of Allie Wade was spelled Gillespie. The Hales who married Lewis Wade, Sarah Wade and Nancy Wade also must have been related. John Wade who married Alley Hale on 07 March 1814, with John Hale as surety, may have been the son of Castleton Wade and Judith Chancellor. (*Marriage Bonds of Franklin County, Virginia, 1786-1858.*) Nancy Wade was born in 1799, married Dr. Jeremiah Pickett Hale (born 1797 in Virginia), after her father made his will, and died on 15 February 1908 in Pikeville, Tennessee. Nancy Wade was identified as a daughter of Lewis Wade when Jeremiah Hale, son of Francis Hale, got a bond to marry her on 03 January 1827, with Castleton Wade as surety. (*Marriage Bonds of Franklin County, Virginia, 1786-1858.*)

John Hale and Susannah Wade had at least three sons and a daughter, Thomas Hale, who married Ann Troup on 08 April 1824, William Hale, Jesse Hale, and Rachel Hale, who married Fleming Janney on 23 September 1824.

William N. Hale, son of John Hale and Susannah Wade, married his first cousin, Elizabeth "Betsy" Wade, daughter of Castleton Wade and Judith Chancellor. William and Betsy had a son Lewis Hale, who married Sarah "Sally" Sigmon. Their youngest son Walker Clayton Hale married Sarah Walker Peters. They were grandparents of Carolyn Hale Bruce. Rachel Jones, who married Royal Wade, was a daughter of John and Mary (Rentfro?) Jones. John Jones lived in the area of Franklin County when it was Halifax County, Virginia.

Hannah Jones, who married John Wade, was a daughter of Henry Jones and Frances Bohannon and a first cousin of Rachel Jones, who married Royal Wade. Henry Jones, who died in Floyd County, Virginia, in 1831, and John Jones were sons of Robert Jones and Mary Van Meter, who moved from Frederick County, Virginia, to the part of Lunenburg County that became Halifax County. Frances Bohannon Jones was a daughter of William Bohannon and a sister of John Bohannon, who married Helen Cook. (Jones data of compiler.) Hannah Jones Wade apparently died before 15 April 1843, when John Wade made his will which was proved in Floyd County, Virginia, in April 1849. She was not among his legatees which included the following children, Henry Wade, Nathan Wade, John Wade, Jr., Owen Wade, Anna Cox, Frances Stigleman, Elizabeth Epperly, Mary Weddle, Nancy Slusher, Alley Epperley, wife of William, and Ruth Magatha, wife of James. A granddaughter, Hannah Magatha, was also an heir. The sons were bequeathed the land on which they were living and the land upon which John Wade resided was left to Isaac Wade, if he survived the testator. Although Isaac was not identified as a son, he must have been such, since the will referred to his "full part of the estate" and to previous advances against it. Son Owen Wade and Burwell Hylton were appointed as executors. The will was witnessed by Burwell Hylton, Abraham J. Jones and Isaac Wade. (*The Wade Quarterly*, Volume 4, Issue 2, September 1977.)

Isaac Wade married Martha Slusher, daughter of Peter Slusher, in 1838. Nancy Wade married Joseph Slusher, son of Peter, in 1839. (*The Wade Quarterly*, Volume 4, Issue 2.) Franky Wade, daughter of John Wade, and John Stigleman, son of Philip Stigleman, were married on 14 December 1811, with John Craig as their bondsman. Elizabeth Wade and Jacob Epperly and Ally Wade and William Epperly were married on the same day, 07 January 1820, with John Wade as surety for both bonds. Nathan Wade married Delphia Cox and had a son, Noah Wade, who married Martha Phillips. Their daughter, Sabra Wade, married William Austin Duncan and had a daughter, Lovell Duncan, who married Harless James Akers. They were the parents of Loretta Akers, who married Willie Altizer. (Data of Loretta Akers Altizer, Radford, VA, 1979.) Nathan Wade, son of John and Hannah Wade, who married Delphia Cox, also had a son, John C. Wade. (*The Wade Quarterly*, Volume 4, Issue 2; data of Edith Duncan Cox, Riner, VA, 1977.) Delphia Cox, who was born in 1804, was a daughter of Braxton Cox and Nancy Allison. (*The Wade Quarterly*, Volume 6, Issue 4, March 1980.)

Anna Wade Cox, daughter and heir of John Wade and Hannah Jones, was born on 26 December 1790, married Ross Cox, son of Carter Cox and Ann Wade, and died on 06 January 1864. Ross Cox was killed by a runaway team on 06 November 1851. Henry Wade, son of John and Hannah, was born in 1806 and married Elizabeth Cox, daughter of Ambrose Cox, on 22 February 1826. Elizabeth Cox Wade was born on 22 July 1802. Ambrose Cox, a brother of Carter Cox (1762-1852), also had a son, Luke

Cox (1792-1862), who married (1) Sarah "Sally" Worrell and (2) Nancy Cox Slusher, daughter

of Carter Cox and Ann Wade and widow of David Slusher. By Nancy Cox Slusher, Luke had a daughter, Ruth J. Cox, who was born in 1841, married John W. Wade on 03 March 1859 and died on 08 November 1881. John W. Wade was born in 1825 and was killed in 1864, during the Civil War. (*The Wade Quarterly*, Volume 4, Issue 2; data of Edith Duncan Cox.)

Ann Wade, who married Carter Cox, had not been connected with the family, but, given all of the intermarriages, she probably was a daughter of James Wade, Jr. Since Carter Cox was identified as Carter Cox, Sr., Carter and Ann Wade Cox must have had a son, Carter Cox, Jr., plus four other known children, Matthew Cox, Ross Cox, who married Ann Wade, Nancy Cox (born on 07 August 1794 and died on 26 June 1880), who married David Slusher, Susannah Cox, and Elizabeth Cox (1789-1859), the second wife of Anderson Wade. (*The Wade Quarterly*, Volume 4, Issue 2.)

Mildred "Milly" Wade Carter, the first wife of Anderson Wade, was a daughter of Waddell Carter and Mildred Wade. Waddell Carter died in Prince Edward County, Virginia, in 1782 and his widow married Robert Anderson on 19 April 1790. Robert Anderson was surety on the marriage bond for Anderson Wade and Milly Wade Carter in 1799 in Prince Edward County. Mildred Wade Carter Anderson was a daughter of James Wade Jr. (IV), who died in Prince Edward County in 1801, and his wife Mary. His father James Ballinger Wade (III), whose wife may have been named Dorothy, lived in Hanover County and died in Amelia County, Virginia, in 1776. (*Wade Waid Waide*, Mrs. Jeff Wade, Jr., Bragg City, MO, 1975; *The Wade Register*, Volume 8, Issue 3, Evelyn Wade, Llano, TX, December 1981.)

Robert Anderson and Mildred Carter, widow of Waddle Carter, obtained a marriage bond in Prince Edward County on 19 April 1790, with James Wade, Jr. as surety. Anderson Wade and Milly Wade Carter, daughter of Waddill Carter, deceased, got a bond to marry in Prince Edward County on 10 December 1799. Robert Anderson, the surety, stated that Milly was his step-daughter. (*Marriage Bonds and Ministers' Returns of Prince Edward County, Virginia, 1754-1810*, Catherine Lindsay Knorr, Pine Bluff, AR, 1950.)

Henry Troup (Troupe), who married Dolly Wade on 16 January 1794 in Franklin County, Virginia, was a son of Jacob and Mary Troup. Jacob Troup died at Yorktown, leaving his widow Mary, son Henry and daughters Sarah and Mary. Sarah Troup married (1) Turpin Rentfro, son of the Reverend Moses Rentfro, and (2) Enos Miles, son of Samuel Miles and Sarah James, in Montgomery County, Ohio, on 12 March 1812. Many members of the Rentfro family were killed in 1780, when Indians attacked Rentfro Station, which was established by Moses Rentfro at the confluence of the Red and Cumberland rivers in, what became, Tennessee in 1779. Mary Troup, Jr. married Peter Mikesell on 15 August 1797, with Henry Troup as surety on the bond. (*Chronological Index of the Renfro Family in the United States, 1700-1850*, Donald Ott Manshardt, M.D., Peoria, IL, undated, photocopy from Ruth Smitt, Walkerton, IN, 1986; *Marriage Bonds of Franklin County, Virginia, 1786-1858*; data of Mildred Christie Barnes.) Troup, who witnessed the will of Owen Ruble, with Castleton Wade and John Hale, on 06 March 1824 in Franklin County, must have been a son of Henry Troup and Dolly Wade. Jacob Troup was surety on the marriage bond for Mary Troup, daughter of Henry and Dorothy Troup, and Landon Peters on 16 October 1817 and for Allie (Alla) Troup, daughter of Henry and Dorothy Troup, and William Peters on 12 December 1818. (*Marriage Bonds of Franklin County, Virginia, 1786-1858.*)

Rachel Lemmon (Lemon), who married Bradley Wade on 05 February 1810, may have been a daughter of Isaac Lemmon, who secured their marriage bond. (*Marriage Bonds of Franklin County, Virginia, 1786-1858.*) Bradley and Rachel Lemmon Wade had a son, Robert A. Wade, who married Sallie Haynes and had a son, William T. Wade, who married Elender Hale. They had a son, Alanza M. Wade, who married Ida Ruth Raikes and had a son, James B. Wade, who married Gene Slusher. They had five children, Sandra Gene Wade, who married Bobby Dean Mullins, James Richard Wade, who married Shirley Ann Wimmer, William Buford Wade, who married Linda Lee Croy, Eleanor Lynn Wade, who married William Martin Bailey, and Albert Maynard Wade, who married Jacquelyn Marie Poe. Jim and Gene Slusher Wade have fourteen grandchildren. (Data of Gene Slusher Wade, Roanoke, VA, 1985.) Robert Wade and Sarah Haynes, daughter of Drewry, were married on 07 February 1850, with Isaac Wade as surety. (*Marriage Bonds of Franklin County, Virginia, 1786-1858.*)

Owen Ruble, Castleton Wade and Henry Troup witnessed a deed from William Standifer of Knox County in the North Carolina Territory south of Ohio River (Tennessee) to Thomas Prothero on 30 November 1793, for 232 acres on the waters of the Pigg River in Franklin County, for 30 pounds. (Franklin County Deed Book 3, page 79, *Abstracts of the Eighteenth Century Deed Books of Franklin County, Virginia, Volume II.*)

Anderson Wade, whose name was transcribed as Alexander, and Elizabeth Cox, daughter of Carter Cox, were married in Montgomery County, Virginia, on 28 November 1808, with David Thompson as surety. (Marriages of Fincastle and Montgomery counties, Virginia, 1773-1831, *The Wade Quarterly*, Volume 3, Issue 1.)

Anderson Wade was enumerated in the Western District of Floyd County, Virginia, in 1850, living with James Hill, aged 34, and his family (#869). Anderson Wade, aged 65, a farmer, was born in Virginia. His wife Elizabeth, aged 63, was born in Floyd County. (*The Wade Quarterly*, Volume 2, Issue 1, June 1975.) This computes to a birth year of 1785 instead of 1772 as was otherwise suggested as the birth year of Anderson Wade, son of John Utley Wade. Also the age 63 does not match the birth year of 1789, otherwise assigned to Elizabeth Cox Wade.

There was a Carter Wade (#276), aged 27, farmer, born in Floyd County, with wife Sarah, aged 29, and children, Mary E. Wade, aged 5, Asa Wade, aged 4, and Emeline Wade, aged 1, who must have been connected with Anderson and Mildred Carter Wade.

There was a John Wade (#855), aged 23, born in Floyd County, with wife Mary, aged 22, and a son Jacob, under 1 year, who could have been a son of Anderson Wade. In addition to the marriage of Anderson Wade to Mildred Wade Carter in Prince Edward County, a couple of name coincidences suggest connections, albeit indirect, from Anderson Wade and his brother, John Wade, to the Wade family of Prince Edward County. There probably is a connection between the husband of John's daughter, Mary Wade Weddle, and Waddell Carter, who married Mildred Wade and had Mildred Wade Carter, who married Anderson Wade. Similarly it is likely that Carter Cox, the father of Nancy Cox, who married David Slusher, and of Elizabeth Cox, the second wife of Anderson Wade, was somehow related to Waddell Carter.

Isaac Lemmon (Lemon) who secured the marriage bond for Bradley Wade and Rachel Lemmon on 05 February 1810 in Franklin County, Virginia, must have been either the father or brother of Rachel, since she named a son, Isaac.

The Franklin County marriage bond for Nicholas Cassell and Alice "Ally" Wade was dated 06 February 1840, with her brother, Isaac Wade, as surety. The transcription described Ally as a daughter of Bradley Wade and his wife Mary. (*The Wade Quarterly*, Volume 2, Issue 1, June 1975.), which probably is a copyist's error, since there is no other indication that Bradley Wade was married to a Mary before 1840. Bradley Wade did get a bond to marry Magdalen Gibson on 04 March 1850, with Nicholas Cassell as surety, which could be for a second marriage for Bradley or, more probably, for the marriage of a son, Bradley, Jr. Nicholas Cassell was bondsman for Isaac Wade and Elizabeth Haynes on 04 February 1842. Isaac Wade was surety for Robert Wade and Sarah Haynes, daughter of Drewry Haynes, on 07 February 1850 (*Marriage Bonds of Franklin County, Virginia, 1786-1858*).

The parents of Angelica Wade of Goochland County, Virginia, who had John Utley Wade out of wedlock by John Utley III, have not been identified.

Of the early Wade contemporaries of Goochland County, who could have been her father, the children of only one couple, Richard Wade, Sr. and his wife Griselle, are known from their wills. His was dated 21 August 1755 and proved 15 November 1757 and hers was dated 12 January 1768 and proved 15 March 1768. Neither mentioned Angelica Wade or John Utley Wade as heirs (Goochland County, Virginia, Will Book 7, page 214 and Book 9, page 132). Since Richard Wade, Sr., who lived on Tuckahoe Creek in Goochland County, and his family attended Dover Church during the ministry of the Reverend William Douglas, as did the younger John Utley Wade, it is likely that the two Wades were related, perhaps as uncle and nephew.

The use of the given names of Castleton, Royal, Anderson and Bradley for their sons, by John Utley Wade and Alice Woodrum, suggest that these were family surnames that could apply to the mother of Angelica Wade or to the mother of Alice Woodrum Wade.

Richard Wade was granted 400 acres of land in Henrico County, Virginia, on 20 February 1723, for 40 shillings and the head rights of eight persons that he claimed for importing them to the colony, Frances Nicholas, Philip Lake, William Stewart, William Clerk, Elizabeth Taylor, Katherine French, William Browne and Miller Harris. (Patent Book 11, page 309, *Cavaliers and Pioneers*, Volume III, Nell Marion Nugent, Virginia State Library, Richmond, 1979.) A patent to Robert Willis, on 17 August 1725, described his 350-acre tract in Henrico County as being on the north side of the James River and the north side of Hardins Branch, next to Richard Wade. (Patent Book 12, page 320.) On 28 September 1728, for 40 shillings, Richard Wade received a patent for 400 acres of land in Goochland County in the fork of Tuckahoe Creek, adjoining Robert Willis, Laforce and Wood or Ware. (Patent Book 13, page 374.) On 24 March 1725 John Utley (Sr.) also obtained a patent for 400 acres of land in Henrico County on Little Tuckahoe Creek, adjoining Rene Laforce, (Patent Book 12, page 409.) which indicates that he and Richard Wade were neighbors and provides for a connection between Richard Wade and Angelica Wade who had a bastard son by John Utley III.

If the reference to the fork of Tuckahoe Creek meant the juncture of Tuckahoe Creek and Little Tuckahoe Creek, the land of Richard Wade was just inside Goochland County from Henrico County, about 14 miles west of Richmond. Rising in Hanover County and flowing south, Little Tuckahoe Creek forms the boundary between Goochland and Henrico counties just before joining Tuckahoe Creek. Tuckahoe Creek rises near Oilville in Goochland County and flows east, along Highway 250, until about six miles north of Highway 6, where it turns south and meets Little Tuckahoe to form the remaining boundary between Goochland and Henrico counties. The merged stream continues south, going under Highway 6 about four miles east of Manakin, into the James River. The land along Tuckahoe Creek is swampy and named the Big Swamp. However the land within the fork is high ground, rising to 200 feet above sea level. Interstate Highway 65 parallels Tuckahoe Creek from west to east in Goochland County. Goochland was formed from Henrico in 1728. Hanover County was erected in 1721 from New Kent County. (State of Virginia General Highway maps.)

On 15 November 1736 Richard and Griselle Wade of St. James Parish, Goochland

County, sold to James Wade of the same place, for 30 pounds, 240 acres in Goochland County in the fork of Tuckahoe Creek upon which James Wade was living. The tract was part of the land granted to Richard Wade on 28 September 1728.(Goochland County, Virginia, Deed Book 2, page 264, abstracts by Mrs. Louis H. Hill, Gonzales, TX, 1973, copies from Lloyd H. Buchwald, Santa Fe, NM, 1977.) It is significant that John Utley witnessed the deed. On 17 November 1741 James Wade of St. James Parish, Goochland County, sold to Giles Letcher of the parish and county of Henrico, for 27 pounds, 135 acres of that tract, which was described as being on the north side of the James River and bounded by Hazel Branch and Henry Ward. (Goochland County, Virginia, Deed Book 3, page 104.) Elizabeth Wade, the wife of James Wade, relinquished her right of dower in the land sold to Giles Letcher in Goochland Court. (*Goochland County, Virginia, Wills and Deeds, 1728-1736*, Benjamin B. Weisiger III, Richmond, VA, 1984.)

James Wade moved to Blissland Parish, James City County, before 09 March 1749/50, when he conveyed the remainder of his land in Goochland County to Strangeman Hutchins (Hutchens) of Goochland County. Sold for 30 pounds, the 105 acres were described as being in the fork of Tuckahoe Creek adjoining Leonard Henly, Jr., John Barnet, Jr., Giles Letcher and Henry Ware, who was called Ward in the previous deed. (Goochland County, Virginia, Deed Book 6, page 60). When Richard Wade sold some of his land to Leonard Henly (Henley) of Blissland Parish, James City County, on 17 March 1734, it was identified as being partly in Goochland County on Little Tuckahoe Creek and partly in Henrico County on Little Drinkinghole branch. (Goochland County, Virginia, Deed Book 2, page 65.)

Strangeman Hutchins, who was born in 1707 and lived on the James River in Virginia before moving to Surry (now Yadkin) County, North Carolina, married Elizabeth Cox and had a daughter Lydia Hutchins who married John Johnson and had Agatha Johnson who married George Adams, son of William Adams and Susannah Martin, who were Quakers who moved from Pennsylvania to North Carolina. This association with Quakers suggests that the Wades of Virginia were connected with the Quaker Wades of Maryland.(Martin, Adams, Johnson data of compiler.)

James Wade, who purchased land from Richard Wade in Goochland County in 1736, with John Utley as a witness, and then sold it in two parcels, first, as a resident of Goochland County in 1741 with wife Elizabeth, and, second, in 1749-50 as a resident of James City County, may have lived previously in Hanover County. James Wade of Hanover County in 1734 lived in St. Pauls Parish adjacent to Vinkler Cobbs, Edward Bullock, Richard Bullock, William Winston and Thomas Glass. Other Wades in Hanover County at this time were William Wade, Edward Wade, Jr., Henry Wade, Jr., John Wade and Robert Wade: (*Hanover County, Virginia, Court Record Book, 1733-1735*, Charles P. Blunt IV, Richmond, VA, 1978.)

For the faithful performance of this deed (05 December 1734) I, Vinkler Cobbs, of Saint Paul's Parish £28 current money ... paid by John Humber ... do convey ... a tract in Saint Paul's Parish ... 99 acres ... oak of Edward Bullock's ... tree of James Wade and William Winston's ... on Thomas Glass' land ... tree of Richard

Bullock's ... it being the land formerly belonging to John Brown. Witnesses: John Crawford, Walt Leak and Robert Wheeler. Deed acknowledged and Judith, wife of Vinkler Cobbs, relinquished her right of dower (05 December 1734).

Vinkler Cobbs, Thomas Standley and James Wade witnessed the will of Edward Penick of Saint Paul's Parish on 27 December 1734.

James Wade and Robert Macoy secured the bond for Timothy Ick as administrator of the estate of Edward Rumball. The bond was acknowledged and recorded on 05 June 1735 in Hanover County.

These records indicate that James Wade of Hanover County was of age in 1734 and, therefore, born before 1713.

Vinkler Cobbs was identified as a resident of Henrico County in a Hanover County indenture, dated 31 August 1734, between Robert Spears, cooper, of Henrico County, and Vinkler Cobbs, carpenter, of Henrico County, for £35 current money ... all that parcel on Matadequin Creek ... 145 acres ... adjacent to the land of David Holt, William Wade, Edward Wade, Jr., and Henry Wade, Jr. ... at the fork of Matadequin Creek. (*Hanover County, Virginia, Court Record Book, 1733-1735.*)

John Wade and John Dabney witnessed a Hanover County deed on 05 July 1737 between George Matlock and John Matlock, Jr., both of Hanover County.

Robert Wade bought land in Hanover County from William Wadkins after 14 April 1720 and sold it to Samuel Rather before 04 January 1734, when Rather conveyed it to Richard Tyree.

Robert Wade of Hanover County, who also had land in Goochland County in 1729, may have been a brother of Richard Wade. On 16 June 1729 Robert Wade, planter of Goochland County, bought 162 acres from Andrew and Susannah Moreman for 60 pounds sterling. Already in Wade's possession, the tract was in St. James Parish, Goochland County, on Byrd (Bird) Creek. (Goochland County, Virginia, Deed Book 1, page 113.) On 22 August 1729 Robert Wade of Goochland County acquired 200 acres from Henry and Elizabeth Reynolds of the same place for 20 pounds. This tract was north of the James River in the main fork of Byrd Creek. (Goochland County, Virginia, Deed Book 1, page 175.) Robert Wade was a resident of Hanover County on 18 March 1734, when he sold 280 acres on branches of Lickinghole Creek in Goochland County, bounded by Henry Harper, Charles Touye's Mill and Mill Creek, to Philip Ryan of Goochland County for 30 pounds. 250 acres of the tract had been granted to Robert Wade by patent and the other 30 acres had been purchased from Henry Harper. (Goochland County, Virginia, Deed Book 2, page 166.) The deed for the 30 acres of land from Henry Harper of Prince George County to Robert Wade of Hanover County was retroactive, being dated 12 November 1734. The tract was described as adjacent to Charles Stoners Mill. (Goochland County, Virginia, Deed Book 2, page number missing.) On 20 August 1734 Robert Wade of St. Pauls Parish, Hanover County, bought from Andrew Moreman of St. Martins Parish, Hanover County,

for 40 pounds, 200 acres in Goochland County on the north side of James River and bounded by Byrd Creek. (Goochland County, Virginia, Deed Book 2, page 62.) Robert Wade of Hanover County sold one of his 200-acre tracts on Byrd Creek in Goochland County to Benjamin Hawkins of Goochland County for 35 pounds, on 02 August 1739. (Goochland County, Virginia, Deed Book 3, page 231.) He sold the other one to Andrew Wade of St. James Parish, Goochland County, for 40 pounds, on 20 August 1739. (Goochland County, Virginia, Deed Book 3, page 265.) Andrew Wade and his wife Elizabeth sold this tract to Obediah Daniel of Middlesex County for 55 pounds on 19 August 1746. (Goochland County, Virginia, Deed Book 5, page 168.)

Since Robert Wade was a resident of Hanover County in 1739, when Angelica Wade appeared before the Goochland County Court regarding the paternity of her son John, it is unlikely that he was her father. The court record indicates that she resided in St. James Parish in 1739.

Byrd Creek drains the area on both sides of the Goochland-Fluvanna county line. It begins in eastern Fluvanna County and crosses into western Goochland County to join the James River at Elk Hill. The two Lickinghole creeks form near Hadenville and the Louisa-Goochland county border and flow from north to south, draining central Goochland County into the James River near the hamlet of Irwin. Little Lickinghole Creek is west of Big Lickinghole Creek. The two streams merge south of the intersection of routes 6 and 600. Mill Creek is a tributary of Big Lickinghole Creek, flowing into the main stream from the east in northcentral Goochland County, south of Route 673. Fluvanna County was established from Albemarle County in 1777. Albemarle was formed from Goochland County in 1744. Louisa County sprang from Hanover County in 1742. (State of Virginia General Highway maps).

Angelica Wade, who lived in Goochland County in 1739, when her son John Utley Wade was born, may have been a daughter of James and Elizabeth Wade, of Goochland County in 1736 and 1741. James and Elizabeth Wade have not been connected with James Ballinger Wade who established the Wade family of Prince Edward County, Virginia, but they could have been his parents, since James Ballinger Wade also has been identified as James Wade Jr., a son of James Wade, Sr. (*Wade Waid Waide*.) James Wade IV, called junior in the records of Prince Edward County, was the grandfather of Mildred Wade Carter, who married Anderson Wade, son of John Utley Wade. If her mother Mildred Wade, who married Waddell Carter, and John Utley Wade were close cousins it would account for Anderson Wade doing the unusual by going from Franklin County, Virginia, to Prince Edward County to get married. James Wade (IV) was a son of James Ballinger Wade (III), and his wife Dorothy, who lived in Hanover County and died in Amelia County, Virginia, in 1776. James Ballinger Wade was born before 1720, perhaps by 1713, which makes him of an age to be a brother of Angelica Wade who gave birth in 1739 and, probably, was born about 1720. John Utley Wade might have named his daughter Dorothea in honor of Dorothy, wife of James Ballinger Wade, who could have been his aunt. However, it also has been stated, without documentation, that James Ballinger Wade (III) was born in 1697 and that his father James Wade (Jr.) died in Hanover County in 1740. (*Wade Waid Waide*.) It seems unlikely that James Ballinger Wade (III) was born as early as 1697. Perhaps this

birth year should apply to his father James Wade (Jr.), who could be James Wade, with wife Elizabeth, who was in Goochland County in 1741 and James City County in 1749. James Wade, who presumably died in Hanover County in 1740, would then be James Wade, Sr. (I).

Andrew Wade, who bought land in Goochland County from Robert Wade in 1739 and sold it in 1746, probably was he who died in Halifax County, Virginia, in 1766. Andrew Wade of Halifax, who has been identified as a probable son of James Wade, Sr., who died in Hanover County in 1740, appeared on the tithe list for Lunenburg County in 1748. In 1749 he was shown as Anderson Wade but thereafter as Andrew. Halifax County was erected from Lunenburg County in 1752 and Lunenburg came from Brunswick County in 1732. Amelia County, which was set up in 1734 from parts of Brunswick and Prince George counties, is not far from the adjoining counties of Hanover and Goochland. Prince Edward County was created in 1753 from Amelia County. Prince George County was founded in 1703 from Charles City County. James City County is down river from Goochland County. (Virginia Highway maps.) Andrew Wade had a son, William Wade, who died in Mecklenburg County, Virginia, in 1799. (*Wade Waid Waide.*)

There was a John Wade in Goochland County in 1732 who might have been the father of Angelica Wade. He was plaintiff in a lawsuit against John Pleasants for trespass which was heard in July Court 1732. The jury found for the plaintiff, but the decision was reversed by the court. (Goochland County, Virginia, Order Book 3.)

The name for Angelica Wade may have derived from Angela (Aungilow) Wade, who witnessed the will of John Wade in York County, Virginia, on 12 February 1722/3. Excepting for a Bible left to his cousin John Wade, the testator bequeathed all of this property to his wife Mary, who was also named as executrix. Proved in York County Court on 18 March 1723/4, the will was also witnessed by John Allen and Robert Allen. (York County, Virginia, Records 16, pages 203-204, abstract, *Wade Waid Waide.*) York County replaced Charles River County in 1642/3 and fostered New Kent County in 1654. Hanover County came from New Kent County in 1721.

The vestry book and register for St. Peters Parish of New Kent and James City counties, Virginia, for the period 1684-1786, contains the birth of Angelica, daughter of Nicholas Lewis, on 20 March 1712. William Lewis, son of Nicholas and Elizabeth Lewis, was born on 22 March 1715. Nicholas and Elizabeth Lewis may have moved to Goochland County where Angelica Lewis and her husband John Ford had a daughter Sally Ford, who was born on 31 December 1756 and baptized on 11 April 1757. Since John Utley III married Ann Lewis, perhaps there is a connection between Angelica Lewis Ford and Angelica Wade. (Data of Kay Lamb, Rockwood, TN, 1979.)

Philip Wade, son of James Ballinger Wade, died in Prince Edward County, Virginia, in 1795, leaving bequests to the sons of James Wade, Jr. (*The Wade Quarterly*, Volume 3, Issue 2, September 1976.) James Wade, Jr., who was also named as an executor, (*The Wade Register*, Volume 8, Issue 3, December 1981.) must have been his brother James Wade IV who died in Prince Edward County in 1801. The will of Philip Wade

was dated 13 October 1795 and proved in Prince Edward County on 19 October 1795. (Prince Edward County, Virginia, Will Book 3, page 2.) Since she was not named as a legatee, the wife of Philip Wade apparently died before him. The children and heirs of Philip Wade were, Delphia Morton, Moses Wade, Hannah Wilson, Sarah (Lucy) McKinney, Bartlett Wade, Daniel Wade, Hampton Wade, Frances "Fanny" Garrett and Martha "Patsy" Green. Use of the name Hampton for a son suggests a connection with Robert Wade, who died in Halifax County, Virginia, about 1770, with a son named Hampton Wade.

The spouses of Daniel Fountain Wade, who died in Halifax County, Virginia, in 1849, Patsy Wade and Hampton Wade, were children of Thomas Green and Lucy Davis, daughter of Peter Davis. Moses Wade married Fanny Ferguson on 29 September 1779 (1789?) and was a Revolutionary soldier. Delphia Wade married ----- Morton. Hannah Wade married ----- Wilson. The wife of Bartlett Wade is not known. (*The Wade Quarterly*, Volume 6, Issue 4, March 1980.) Daniel Wade married Lucy Davis Green on 15 September 1785 in Prince Edward County, with consent of her father Thomas Green and with Parrish Green as surety on the bond dated 14 September 1785. Patsy Wade married Parrish Green on 23 December 1784 in Prince Edward County, with consent of her father Thomas Green and with Francis Watkins as surety on the bond dated 21 December 1784. Hampton Wade married Elizabeth Green on 08 January 1795 in Prince Edward County, with consent of his father Thomas Green and with Thomas Fears as surety on the bond dated 07 January 1795. Frances Wade was bonded to marry Thomas Garrett on 04 July 1794 in Prince Edward County, with Hampton Wade as surety. Lucy Wade married Nevin McKinney on 20 December 1785 in Prince Edward County. (*Marriage Bonds and Ministers' Returns of Prince Edward County, Virginia, 1754-1810.*)

Polly Wade, daughter of Charles Wade, deceased, and Jacob Price obtained a marriage bond in Prince Edward County on 07 September 1789, with Joseph Venable as surety. Betsy Wade, daughter of Charles Wade, and John Bass got a bond to marry in Prince Edward County on 21 January 1793, with James Wade as surety.

Mahala Wade, daughter of William Wade, who consented, and David Reynolds got a marriage bond in Prince Edward County on 16 January 1809, with Robert Lancaster as surety.

According to his application for a Revolutionary War pension, John Wade, who lived in Owen County, Kentucky, when his pension began on 16 April 1833, was born on 05 June 1753 in Prince Edward County, Virginia, and a son of James Wade. John Wade joined the army while residing in Prince Edward County. (National Archives file number missing.) He must have been a son of James Ballinger Wade (III), because James Wade IV and Philip Wade apparently did not have surviving sons named John.

Owen County, Kentucky, which was formed in 1819 from parts of Scott, Franklin and Gallatin counties, was named for Colonel Abraham Owen who was born in Prince Edward County, Virginia, in 1769, moved to Shelby County, Kentucky, in 1785 and was killed at the Battle of Tippecanoe in 1811. He was a son of Bracket Owen, who

established a station in Shelby County in 1782, near where Shelbyville now stands. (*History of Kentucky*, Volume II, Lewis Collins, 1846-7, revised Richard A. Collins, A.M., LL.B., 1874, reprinted Kentucke Imprints, Berea, KY, 1976.) Bracket Owen and James Carter appraised the inventory of Leonard Wade, son of James Wade (IV), in Prince Edward County on 24 May 1782. (Prince Edward County, Virginia, Will Book 1, page 282.)

James Carter probably was related to Waddell Carter and there may have been a familial relationship between the Owen and Wade families since John Wade, the son of John Utley Wade, named one of his sons Owen Wade. The connection with the Owen family might have influenced Royal Wade to move to Shelby County.

There was a Carter Wade in Hanover County, Virginia, from 1797 until 1809. (*Hanover County Taxpayers, St. Paul's Parish, 1782-1815*, William Ronald Cocke III, Columbia, VA, 1956.)
