An analysis of the available Wade data and family traditions suggests that James Wade, Jr., who was born in 1697, son of James Wade, Sr. who died in Hanover County, Virginia, in 1740, was the James Wade, who lived in Goochland County, Virginia, in 1741, with wife Elizabeth. (Goochland County, Virginia, Deed Book 3,page 104; Book 6, page 60; Wade Waid Waide, Mrs. Jeff Wade, Jr., Bragg City, Mo,1975; and Goochland County, Virginia, Wills and Deeds, 1728-1736, Benjamin B. Weisiger III, Richmond, 1984.) The maiden name of James' wife Elizabeth is not known, but, since it appears that she was the mother of James Ballinger Wade, perhaps it was Ballinger.

Undocumented family records show that Mildred Wade Carter, who married Anderson Wade in Prince Edward County, Virginia, on 13 December 1799, was a daughter of Waddell Carter and Mildred Wade, who was a daughter of James Wade, who died in Prince Edward County in 1801. James Wade, who died in 1801, was a son of James Wade, who was born in 1697, and his wife Dorothy. James Wade, who was born in 1697, was a son of James Wade, who died in Hanover County, Virginia, in 1740. (Wade Waid Waide.) This lineage seems to leave out a generation when compared to another undocumented family record. James Wade, who died in Prince Edward County in 1801, was an executor and apparently a brother of Philip Wade who died there in 1795. Philip Wade was a son of James Ballinger Wade, who was born about 1742 in Hanover County, Virginia, served in the Revolutionary War and died in Amelia County, Virginia, in 1776. His wife may have been named Dorothy. Philip Wade and his wife, who may have been named Sarah, had a son, Daniel Fountain Wade, who was born in Halifax County, Virginia, in 1760, married Lucy Davis Green in Prince William County, Virginia, in 1785, and died in Halifax County in 1849. (The Wade Register, Volume 8, Issue 3, Evelyn Wade, Llano, TX, December 1981.) To have a son in 1760, Philip Wade must have been born about 1740 and married by 1759. This makes it impossible for Philip Wade's father James Ballinger Wade to have been born in 1742. He must have been born by 1720, perhaps as early as 1713, and could have been a son of James Wade,

Jr. and his wife Elizabeth, whose maiden name may have been Ballinger, to account for the middle name of James Ballinger Wade. If James Ballinger Wade died in 1776, it is unlikely that he served in the Revolutionary War.

James Wade, Jr., who was involved with Philip Wade through his will, apparently was a brother of Philip and, therefore, was James Ballinger Wade, Jr. (IV). In addition to Mildred Wade, who married Waddell Carter and had a daughter Mildred Wade Carter who married Anderson Wade in Prince Edward County in 1799, James Wade (IV) and his wife Mary also had a daughter, Lucy Carter, who married Edward Haskins. Haskins died in Prince Edward County, Virginia, in 1807. Their daughter Mildred Wade Haskins married Daniel T. Boisseau, and died in Simpson County, Kentucky, about 1840-1850. They were ancestors of Marion Sherman, Oshkosh, WI. (*Wade Waid Waide.*)

The father of James Ballinger Wade (III) must have been related to Charity Wade, who was born in New Jersey in 1694, married Joseph Ballinger there about 1720 and died after 1744. Joseph Ballinger, son of Henry Ballinger and Mary Harding, was born in Burlington, New Jersey, in 1691. Joseph Ballinger and Charity Wade moved from New Jersey to Goochland County, Virginia, where his will was proved on 19 February 1744. Joseph and Charity Wade Ballinger had, among other children, a daughter, Mary Ballinger, who married Pearce Wade about 1747, and a daughter, Charity Ballinger, who married Jeremiah Wade. Pearce and Jeremiah Wade may have been sons of Robert Wade of Hanover County, Virginia. Pearce Wade was born in 1720 and died in 1770 in Amherst County, Virginia. (Three Centuries of Ballingers in America, Emma Barrett Reeves, Texian Press, 1977.) Jeremiah and Charity Ballinger Wade lived in Goochland County, Virginia, before moving to Bedford County, Virginia, where he died in 1772. The will of Jeremiah Wade, dated 08 July 1772 and proved in Bedford County on 28 September 1772, directed his executors, Richard Ballinger, James Hilton and Nathan Hilton, to sell his estate and, after paying his debts, divide the proceeds between his children, whom were not identified. It was witnessed by Abraham Ervine, Jesse Hilton and Elizabeth Mitchell and proved by the oaths of Ervine and Hilton. James Hilton, who served as executor, with Guy Smith as his security, made an inventory and appraisement of the estate on 10 October 1772 and returned it to Bedford County Court on 22 November 1779. It included household furnishings, livestock and corn, but no tools. (Bedford County, Virginia, Will Book 1, pages 163-164 and 360-361.)

The association with the Hilton family suggests a connection with John Wade, son of John Utley Wade, whose Floyd County, Virginia, will was witnessed by Burwell Hilton (Hylton) in 1843. (*The Wade Quarterly*, September 1977.)

Bedford County was formed from parts of Lunenburg and Albemarle counties in 1754. Albemarle came from portions of Goochland and Louisa counties in 1744. Franklin County was established in 1786 from areas of Bedford and Henry counties. Henry County came from Pittsylvania County in 1777. Pittsylvania emerged from Halifax County in 1767. Halifax was created from Lunenburg County in 1752. (Virginia State Highway maps.)

The will of James Wade of Prince Edward County, dated 01 January 1801, named as legatees, son James Wade, daughter Milly Anderson, son Anderson Wade, grandson Anderson Wade, grandson James Wade, granddaughter Milly Wade, wife of Anderson Wade, granddaughter Leona Wade, grandson James Wade, son of Charles Wade, granddaughter Elizabeth Carter, daughter of Waddell Carter, granddaughter Milly Wade Bushel, daughter of John Bushel, and granddaughter Polly Wade, daughter of James Wade. (abstract, Prince Edward County, Virginia Will Book 3, page 215, Richard Brenneman, *The Wade Quarterly*, Volume 3, Issue 2, September 1976.) The parents of granddaughter and heir Leona Wade were not identified, but she may have been a posthumous daughter of Leonard Wade whose widow was pregnant in 1781.

The will of Charles Wade was dated 10 December 1781 and proved 20 May 1782. In it he mentioned his four children, Mary, Anderson, Elizabeth and James Wade, and his brother Leonard, deceased, whose widow was with child. He named his wife Elizabeth Wade, father James Wade, Waddell Carter and Major John Clark as executors. The will was witnessed by Thomas Kidd, Francis Kidd and Thomas Morris.(abstract, Prince Edward County, Virginia, Will Book 1, page 298.)

A settlement of the estate of Leonard Wade on 24 May 1782 was administered by Sally Wade who probably was his widow. James Carter and Bracket Owen appraised his inventory. (abstracts, Prince Edward County, Virginia, Will Book 1, pages 282 and 326.)

Dated 13 October 1795 and proved 19 October 1795, the will of Philip Wade named his children, Delphia Morton, Moses Wade, Hannah Wilson, Sarah McKinney, Bartlett Wade, Daniel Wade, Hampton Wade, Fanny Garret and Martha Green as legatees, with the sons of James Wade, Jr. (abstract, Prince Edward County, Virginia, Deed Book 3, page 2.)

Since this compiler has not seen absolute proof substantiating the tradition that Anderson Wade, son of John Utley Wade of Franklin County, Virginia, married Mildred Wade Carter in distant Prince Edward County, the suspicion arises that it would be more logical if Mildred Wade Carter had married her neighbor, Anderson Wade, son of Charles Wade of Prince Edward County, despite the fact that they were first cousins.
